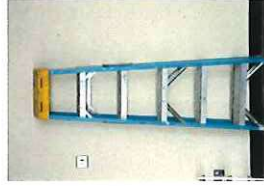

RECENT SETTLEMENTS



§ Plaintiff slipped and fell off a ladder at a construction site sustaining injuries to his lower back: \$1.25 Million Settlement

§ Plaintiff was a pedestrian inside of a dry cleaners when defendant's vehicle came through the storefront. She sustained multiple fractures of her hips, lumbar spine, leg and shoulder requiring multiple surgeries. She also sustained scarring of her face, right shoulder and disfigurement of her thigh: \$1.26 Million Settlement

§ Plaintiff was a field engineer working in a building where he fell 25 feet down an uncovered hole. He sustained multiple fractures to his left ankle, left fibula, left rotator cuff and labrum: \$1.2 Million Settlement

§ Plaintiff sustained injuries to his back, right shoulder and right knee in a motor vehicle accident: \$929,000.00 Settlement

§ Plaintiff's truck at a construction site flipped over causing injuries to his back and knees: \$850,000.00 Settlement

§ Plaintiff tripped and fell over defective materials at construction site resulting in injuries to his back and knees: \$1.45 Million Settlement
